SWIM AT YOUR OWN RISK - NO LIFEGUARDS ON DUTY

April 2, 2018

Dear Homeowner:

There will be NO LIFEGUARDS ON DUTY again this year. Therefore, the following requirements must be met in order to use the pool facilities:

- <u>ALL RESIDENTS</u>: You must be a resident in good standing and/or a guest of a resident member in good standing. *Keep your tags! Tags will be used year after year*;
- **NEW RESIDENTS:** You must acknowledge receipt and understanding of all pool rules listed in this letter *and sign and return pages 3 and 4*;
- NEW RESIDENTS: You must <u>sign and return pages 3 and 4</u> to Community Solutions via email to service@csutx.com, fax to 713-344-0472 or US mail (see below for contact information). Each access tag will allow access to the pool during the pool's hours of operation. Each home receives <u>ONE</u> free tag. Additional tags can be purchased for \$40.00 each. Please enclose payment for additional tags with your signed waiver. Payments for additional tags are to be made payable to *Falcon Point East*.

The following schedule will be in place for the 2018 swim season. Your access tag will only allow access during the days and times listed below. All access attempts are logged. If you are delinquent on your assessments, your access tag will NOT activate the gate release.

Beginning May 5, 2018 until September 30, 2018. (including Memorial Day & Labor Day)

Monday, Tuesday, Wednesday, Thursday, Friday, Saturday, Sunday - Open 8am to 8pm

POOL RULES

SWIM AT YOUR OWN RISK - NO LIFEGUARDS ON DUTY

- Members and their guests (maximum of two guests allowed per member) are permitted during pool hours.
- Group parties require a reservation of the facility with a \$100.00 usage deposit that is refundable after inspection.
- Members are required to clean up after themselves by replacing all chairs in their proper locations and removing any trash that remains.
- Use of the pool is prohibited for persons with communicable diseases or open wounds.
- Pets are prohibited.
- Alcohol and other drugs are prohibited.
- Smoking is prohibited.
- Glass containers are prohibited.
- Profanity, improper behavior and intoxication are prohibited.
- Horseplay and running are prohibited.
- Children under the age of twelve (12) are not permitted without an adult.
- A supervising adult must be within arms-reach of a child wearing a life preserver.
- All non-toilet trained children must wear swim diapers.
- NO DIVING is permitted.
- The Wading Pool is limited to children 5 years old and younger.
- SUPERVISING ADULTS ARE RESPONSIBLE FOR THE CHILDREN AT ALL TIMES.
