

### SWIM AT YOUR OWN RISK – NO LIFEGUARDS ON DUTY

April 16, 2018

Dear Homeowner:

There will be NO LIFEGUARDS ON DUTY this year. Therefore, the following requirements must be met in order to use the pool facilities:

- **ALL RESIDENTS:** You must be a resident in good standing and/or a guest of a resident member in good standing;
- **ALL RESIDENTS:** You must complete the registration form and initial your understanding of the pool rules before your current tag will be activated;
- **ALL RESIDENTS:** You must acknowledge receipt and understanding of all pool rules listed in this letter **and sign and return page 3;**
- **ALL RESIDENTS:** You must **sign and return page 3** to Community Solutions via email at **service@csutx.com**, fax to 713-344-0472 or via US mail (see below for contact information). Each access tag will allow access to the pool during the pool's hours of operation. Each home receives **TWO** free tags. Additional tags can be purchased for \$50.00 each. Please enclose payment for additional tags with your signed waiver. Payments for additional tags are to be made payable to **Twin Falls.**

The following schedule will be in place for the 2018 swim season.  
Your access tag will only allow access during the days and times listed below.

All access attempts are logged.

If you are delinquent on your assessments, your access tag will NOT activate the gate release.

## **POOL SPECIFIC RULES**

- Members and their guests (maximum of two guests allowed per member) are permitted during pool hours.
- Members are required to clean up after themselves by replacing all chairs in their proper locations and removing any trash that remains. Trash days are Monday's and Thursday's at the front curb.
- Use of the pool is prohibited for persons with communicable diseases or open wounds.
- Pets are prohibited in the pool and splashpad area.
- Horseplay and running are prohibited in the pool and splashpad area.
- Children under the age of twelve (12) are not permitted without an adult in the pool area.
- A supervising adult must be within arms-reach of a child wearing a life preserver.
- All non-toilet trained children must wear swim diapers.
- NO DIVING is permitted.
- SUPERVISING ADULTS ARE RESPONSIBLE FOR THE CHILDREN AT ALL TIMES.
- ENTRY OUTSIDE OF POOL HOURS IS PROHIBITED. ANY VIOLATIONS WILL RESULT IN SUSPENSION OF POOL PRIVILEGES FOR THE SEASON.

## **ALL COMMON AREA RULES**

- Alcohol and other drugs are prohibited.
- Smoking is prohibited.
- Glass containers are prohibited.
- Profanity, improper behavior and intoxication are prohibited.
- No motorized vehicles are permitted on the trails or lakes.

FROM ANY AND ALL LIABILITIES, LOSSES, COSTS, EXPENSES (INCLUDING ATTORNEY'S FEES, COURT COSTS, AND/OR EXPENSES OF LITIGATION), CLAIMS, DAMAGES, CAUSES OF ACTION AND SUITS OF WHATSOEVER KIND OR NATURE WITHOUT LIMIT AND WITHOUT REGARD TO THE CAUSE OR CAUSES THEREOF, OR THE NEGLIGENCE OF ANY PARTY OR PARTIES, INCLUDING THE NEGLIGENCE OF THE HOMEOWNER, THE ASSOCIATION OR ANY OF THE ENTITIES DESCRIBED ABOVE, WHETHER SUCH NEGLIGENCE BE SOLE, JOINT OR CONCURRENT, FOR ANY BODILY INJURY, DAMAGE TO ANY PROPERTY, OR ANY OTHER CAUSES OF ACTION, INCLUDING BUT NOT LIMITED TO, CLAIMS CONNECTED WITH OR ASSOCIATED WITH FALLING, SLIPPING, DIVING OR DROWNING ARISING OUT OF, OR IN CONNECTION WITH, ME AND MY FAMILY, OR ANY OF MY FAMILY'S GUESTS, USING THE POOL. IT IS THE EXPRESSED INTENTION OF THE PARTIES HERETO, BOTH THE HOMEOWNER AND THE ASSOCIATION AND ANY OF ITS ENTITIES, THAT THE INDEMNITY PROVIDED IN THIS PARAGRAPH IS INDEMNITY BY THE HOMEOWNER TO INDEMNIFY AND PROTECT THE ASSOCIATION AND ITS ENTITIES FROM THE CONSEQUENCES OF THE HOMEOWNERS OWN NEGLIGENCE, AND THE ASSOCIATION AND ITS ENTITIES' NEGLIGENCE WHETHER THAT NEGLIGENCE IS THE SOLE CAUSE, OR A JOINT OR CONCURRING CAUSE OF THE INJURY OR DAMAGES.

\_\_\_\_\_ I/we hereby acknowledge that failure to abide by the pool rules will result in suspension of pool privileges for the season.

\_\_\_\_\_ I/we hereby accept all responsibility for any family member(s) or guest(s) using the pool.

\_\_\_\_\_ I/we hereby acknowledge pool access will not be granted if the association fees are not in good standing.

We hereby acknowledge and agree to follow the common area rules and in return, will receive two (2) free access tags. Additional tags may be purchased from the association for \$50.00.
