De Anne Wilson ____, Secretary of the Hannover Forest Homeowners Association (the "Association"), do hereby certify that at a meeting of the Board of Directors of the Association (the "Board") duly called and held on the 14 day of November with at least a quorum of the board members being present and remaining throughout, and being duly authorized to transact business, the following Slide Rules Policy was duly approved by a majority vote of the members of the Board:

RECITALS:

- 1. Chapter 202 of the Texas Property Code was amended to add Section 202.006 (a) to require property owners' associations to file all dedicatory instruments in the real property records of each county in which the property to which the dedicatory instruments relate is located, and (b) A dedicatory instrument has no effect until the instrument is filed in accordance with this section.
- 2. The new law relating to dedicatory instruments becomes effective on January 1, 2012.
- 3. The Board of Directors of the Association desires to adopt rules consistent with the provisions of Section 202.006 of the Texas Property Code.

POLICY:

FILED FOR RECORD 8:00 AM

It is the policy of the Association to enforce the following Slide rules:

All patrons must read and obey all posted signs. (a)

(b) Obey all instructions given by pool staff.

(c) Maximum operational load: 1 person up to 250 pounds. DEC -6 2011

- (d) Riders must be at least 40" tall to ride.
- (e) Swimwear with exposed zippers, buckles, rivets, or metal is not permitted.
- (f) Goggles are not permitted.
- Single riders only No human chains. (g)
- Riders must wait for the swimmers to move out from the slide catch area before going. (h)
- (i) Riders may not dive, run, rotate, or stop on the slide.
- (j) At the end of the slide, riders must obey all instructions from the aquatics personnel and exit quickly.
- (k) Caution: For safety reasons, pregnant women and persons with heart conditions or back trouble cannot ride this slide.
- Riders ride at their own risk. (1)
- (m) Riders may not block the end of the slide.
- (n) USCG approved floatation devices are permitted on the slide.
