If you have not already received your amenity access tags, please read the following:

- You **MUST** acknowledge receipt and understanding of all rules listed ***and sign and return page 3.*** You can send your signed page 3 to Community Solutions via email to **service@csutx.com**, fax to **713-344-0472** or US mail (see below for contact information).
- Each access tag will allow access to the amenities during their hours of operation. Each home receives **TWO** free tags. Additional tags and replacement tags can be purchased for \$40.00 each. Payments for additional or replacement tags are to be made payable to **McCrary Meadows.**
- You must be a resident in good standing and/or a guest of a resident member in good standing. Good standing means all assessments are current AND deed violations are not present.

AS LONG AS YOUR ACCOUNT REMAINS IN GOOD STANDING!**

Access tags will only allow access to the pool during the days and times listed below. All access attempts are logged. If you are delinquent on your assessments, your access tag will NOT activate the gate release.

McCrary Meadows AMENITY & COMMON AREA RULES

POOL RULES

- NO SWIMMING WITHOUT A LIFEGUARD ON DUTY.
- No one will be admitted without a valid McCrary Meadows access card.
- All children under 12 years old must be accompanied by an adult at least 18 years of age.
- Two (2) guests are permitted per valid resident access card.
- Residents who have guests must sign them in and be responsible for them at all times.
- No running or horseplay.
- Profanity, improper behavior and intoxication are prohibited.
- No smoking, no glass containers or alcohol beverages allowed in the pool area.
- Only small floating items, upon pool manager's discretion, will be allowed in the pool.
- No pets are permitted within the pool gates.
- A supervising adult must be within arms-reach of a child wearing a life preserver.
- SUPERVISING ADULTS ARE RESPONSIBLE FOR THE CHILDREN AT ALL TIMES. THE LIFEGUARDS HAVE THE ULTIMATE AUTHORITY AND MAY REMOVE PERSONS FROM THE POOL AREA FOR VIOLATING THESE RULES.

TENNIS & SPORT COURT RULES

- Facilities are for the use of McCrary Meadows residents and their guests only.
- Children 12 and under must be accompanied by an adult.
- Reservations and/or Private Lessons are not permitted.
- Do not abuse the nets.
- No dunking on the basketball rim.
- Proper footwear is required.
- No food, glass, alcoholic beverages or smoking.
- Pets are not permitted.
- No bicycles, roller blades or skate boards.
- **Court Hours: 8am – 9pm**

ALL COMMON AREA RULES

- Alcohol and other drugs are prohibited.
- Smoking is prohibited.
- Glass containers are prohibited.
- Profanity, improper behavior and intoxication are prohibited.
- No loitering or trespassing.
- Common areas are open from dawn to dusk.
- No motorized vehicles are permitted on the common areas, walking trails or lake.
