## **POOL RULES**

- NO SWIMMING WITHOUT A LIFEGUARD ON DUTY.
- No one will be admitted without a valid Walnut Creek pool wristband.
- All children under 16 years old must be accompanied by an adult at least 18 years of age.
- Four (4) guests are permitted per valid resident wristband.
- Members are responsible for the behavior and actions of their guests. Loud, abusive, or foul language is prohibited.
- Proper swimwear is required. Swim diapers are required.
- No diving from the edge of the pool. No running or horseplay.
- Profanity, improper behavior and intoxication are prohibited.
- No smoking, no glass containers or alcohol beverages allowed in the pool area.
- No skate boards, bikes, scooters, etc. are allowed in the pool area.
- Only small floating items, upon pool manager's discretion, will be allowed in the pool.
- No pets are permitted within the pool gates.
- No swimming with open sores or communicable diseases is permitted.
- A supervising adult must be within arms-reach of a child wearing a life preserver. SUPERVISING ADULTS ARE RESPONSIBLE FOR THE CHILDREN AT ALL TIMES. THE LIFEGUARDS HAVE THE ULTIMATE AUTHORITY AND MAY REMOVE PERSONS FROM THE POOL AREA FOR VIOLATING THESE RULES.
