Pursuant to Section 6.08 of that certain <u>Declaration of Covenants, Conditions and Restrictions for North Park South,</u> recorded under Document No. 2024106133, Official Public Records of Montgomery County, Texas, as amended (collectively, the "Declaration"), CENTURY LAND HOLDINGS OF TEXAS, LLC, a Colorado limited liability company (the "Declarant") files this Adoption of Working Capital Assessment as follows:
